

Affidavit of Heirship Form Instructions

This form is not intended as a substitute for the probate of a decedent's estate. Flywheel Energy, L.L.C. reserves the right to request all documents in addition to or in support of this form necessary to verify ownership.

Please use the following guidelines to ensure that the Affidavit of Heirship is completed correctly and copies of required documents are attached:

- 1. The Affidavit of Heirship <u>CANNOT</u> be filled out by any party who stands to benefit from the Estate; including spouses and children of surviving heirs. Please refer to your attorney, CPA, neighbor, pastor, family friend or acquaintance to complete the Affidavit.
- 2. If decedent left a will, attach a certified copy thereof.
- 3. If executor or administrator has been appointed for the estate of decedent, attach a copy of the certificate of appointment from the court which made the appointment.
- 4. If administration on decedent's estate has been completed and final order or decree of distribution has been rendered, attach certified copy of such order or decree.
- 5. If necessary, you may attach the land description on a separate page. Make sure to include the appropriate legal description for recording if required by the state. Confirm with the county clerk's office the necessary requirements.
- 6. All signatures in the Affidavit MUST be notarized.
- 7. The completed, properly executed and notarized Affidavit <u>MUST</u> be recorded in the county where the affected property is located. Contact the county clerk's office to inquire about the recording costs.

- 8. Forms sent to Flywheel Energy without a recorder's stamp will automatically be rejected. Please keep copies of all completed forms and legal documents for your records.
